- A State of Maine Hunting License is required unless you are accompanied by a Penobscot Nation Guide, are a tribal member spouse, or a member of a federally recognized tribe.
- > <u>All</u> permit applications require a tribal member affiliate's signature.
- A non-refundable application fee is required. This fee is waived for non-member spouses. You must enclose a self-addressed stamped envelope to receive a permit.
- Incomplete applications will not be processed.
- Make checks payable to the Penobscot Nation.
- > Tribal members must be at least 18 years of age to accompany non-members.
- Non-member access permits require a Tribal Member be within 1 mile of the territory requested.
- Please be sure to reference the most recent PIN F&G Rules & Regulations for requirements regarding non-member hunting seasons, bag limits, and Tribal Member accompaniment.
- By signing the application form both parties acknowledge all rules, regulations, and requirements set forth by the PIN, DNR, and that non-members hold no Responsibility to the PIN or their Tribal Member affiliates for damages or personal injury while utilizing said permit.
- Only permits bearing a postmark of August 1-31 will be processed (exception: spousal permits).
