# **JOB SUMMARY:**

Responsible for enforcing all applicable fish and wildlife laws, ordinance, and regulations on Penobscot Indian Territory.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- 1. Enforce fish, wildlife, recreation laws/ordinances, and to enforce all other laws and ordinances as they apply.
- **2.** Ability to issue warnings, summonses and making arrests when necessary.
- **3.** Availability to take answer and calls for service.
- **4.** Prepares activity and other required reports.
- **5.** Maintains all equipment issued.
- **6.** Investigate hunting, boating, snowmobile, and ATV accidents.
- 7. Investigate, gather evidence, write reports, and testify in court.
- **8.** Checks camps on P.I.N. lands for vandalism.
- **9.** Follows and obeys all applicable regulations and policies of the S.O.P. manual.
- **10.** Firearm qualification.
- 11. Interacts harmoniously and effectively with others, focusing upon the attainment of Penobscot Nation goals and objectives through a commitment to teamwork.
